One of our biggest accomplishments for 2018 was surely the growth of our medical and dental assistant apprenticeship programs. In addition, bringing services to our first school-based clinic was a major accomplishment in delivering care outside of our traditional clinic walls. In a complementary fashion, our outreach program is now such an integral part of what PCHS does, that it is no longer about attending a particular event – it is, instead, about being a community presence in all the geographic areas where we find our patients at work, at home, and at play. Many of our Community Health Workers partner with individual patients to help overcome barriers to essential care and services.

A big thanks to everyone who played a part in the success that PCHS saw in 2018. We simply can't succeed at being your local community health center without our staff, our local partner agencies, and each and every patient who comes to us for care and thereby helps support our agency which enables us to continue to serve the community.

PATIENT PORTAL

A Patient Portal service was added in late 2016 which allows patients to access their health information and manage clinic appointments. The word was spread and by the end of 2018, 59% of our patients had signed onto the portal.

MOBILE MEDICAL CLINIC

Patients cannot always get to the clinic for their health care concerns, so PCHS will go to them. With wholehearted approval from the PCHS Board of Directors, plans were developed in late 2018. Mobile vans will spread PCHS quality care for medical and behavioral health in 2019.

SIXTH STREET CLINIC REMODEL

The Sixth Street Clinic was our first clinic, moving from small office spaces on downtown Bremerton's Pacific Avenue to expanded offices in a newly renovated building on Sixth Street in 1994. The current remodel is the second one since moving into the building and demonstrates PCHS' commitment to providing care and services to the area.

POULSBO DENTAL CLINIC

PCHS added a fifth dental clinic with the opening of the Poulsbo Dental clinic at the Fishline Comprehensive Services building on Viking Avenue in October. The clinic is part of an innovative collaboration with several of our community partner agencies, offering social services for our community and our patients.

OUTREACH

Outreach started for school-based clinic services for the North Mason School District at the beginning of September. Navigators and Community Health Workers regularly visit various community centers and events to assist with insurance enrollment and provide information about PCHS services.



TITLE X AND FAMILY PLANNING

PCHS became a Title X subcontractee in September supplementing the reproductive health care services we already provide.

COMMUNITY HEALTH WORKERS

The number of PCHS Community Health Workers (CHW) quickly expanded in 2018 to support patient services. In addition to community outreach services, our CHWs help patients and their families navigate community resources, promote healthy behaviors, and help our patients improve and maintain their health status.

APPRENTICESHIP PROGRAM

The medical and dental assistant apprenticeship program begun in 2017 is a success with 100% completion. Graduates accepted our employment offers. A second group has begun their apprenticeship.

Eastside Baby Corner of Bremerton

A partnership with a Bremerton based Eastside Baby Corner (EBC) was formed early in the year. EBC provides free infant and children's items.

RESPITE CARE

PCHS became a partner with Catholic Community Services and CHI-Harrison Medical Center to pilot a homeless shelter with medical respite services. The respite program provides homeless patients who are discharged from the hospital with a place to stay at Benedict House while recovering from illness or injury. The combined housing and medical program was one of the goals of the Kitsap Community Health Priorities plan developed in 2014. Eight people completed the program by the end of the summer.

Medication Blue Box

Kitsap County became the third Washington County to require drug manufacturers to provide drug stewardship. In early 2018, four PCHS pharmacies in Kitsap were installed with a blue drop box as a part of the drug take-back program while Belfair's PCHS pharmacy has a gray box under a separate arrangement. The drop boxes provide an easy and opportunistic place for people to drop off their unused, unwanted, and/or expired medications, keeping these off the street, out of easily accessed medicine cabinets, and helping the environment.

CHOP CHOP

Amerigroup donated \$5,000 toward a Chop Chop cooking workshop for our patients this year. Our dietitian, Holly Wolfe, led the workshops and demonstrated healthy food preparation.





BEHAVIORAL HEALTH PROGRAM GROWS

The Behavioral Health program continued to grow this year with additional psychiatric providers. Telehealth became a regular part of psychiatric visits. PCHS applied for a behavioral health licensure from the Division of Behavioral Health and Recovery to be recognized as a provider of mental health and substance use disorder services.

MEDICATION ASSISTED TREATMENT

Our integrated Medication Assisted Treatment (MAT) program continues to grow - serving over 475 patients with substance use disorders in 2018. We also received county, state, and federal awards to expand our interdisciplinary MAT team in support of improved treatment access and care coordination adding additional chemical dependency professionals, licensed mental health professionals, and community health workers. Collaborating with diverse community partners, our MAT program continues to foster opportunities to outreach, engage, and provide recovery support services to individuals seeking substance use disorder treatment.

PCHS welcomed Senators Patty Murray and Maria Cantwell in 2018 while they hosted meetings in our facilities to explore federal concerns related to opioid abuse.



The NFL/American Cancer Society sponsored event to promote women's health screenings was held in both the Wheaton Way and the Port Orchard clinics in the final Year Two of the grant. We were honored to have several cancer survivors as speakers, as well as Bremerton Mayor Greg Wheeler and Jesse Gritton from the American Cancer Society. The Seahawks SeaGals and mascot Boom helped to liven up the event at the Wheaton Way clinic. Most of the PCHS clinics participated in the focused screening day with over 5,000 receiving care and education. PCHS plans to continue the event as it has become a successful way to help women get these important screenings.

OysterFest




